## **PROFESSIONAL ADMINISTRATOR LICENSE • 2024-2025 Course Schedule**

The Professional Administrator licensure course totals 27 credits over two years. Candidates seek licensure through TSPC with COSA/UO's assistance once all coursework is completed. Contact <u>Trina</u> for more information; trina@cosa.k12.or.us.

The **Clinical Internship** is a total of seven credits, with five credits maximum per term. We recommend taking back-to-back terms. The internship requires a minimum of 200 hours of meaningful district-level experiences distributed across the district-level NELP standards. A university internship supervisor and a district-based supervisor form the supervision team for each candidate. All university internship supervisors are highly qualified and experienced Oregon administrators, and all district-based supervisors must have held an Oregon administrator license for at least three years. During the internship experience, candidates are engaged in reading, discussion board posts and job-embedded assignments.
