COSA Workgroups Report - The 2024 COSA Workgroups Report outlines ten key recommendations from our two workgroups: one focused on Funding, and one focused on Student Supports. These key recommendations have shaped our 2025 Legislative Priorities. Thank you again to our OASE facilitators, and all of the Superintendents and COSA Leaders who participated in one, or both, of the workgroups. HB 2656 Accountability Report - The HB 2656 Accountability Report was published by the Oregon Department of Education in early December. We want to express our gratitude to Dr. Williams and the ODE team for bringing education partners together, organizing the HB 2656 Accountability Workgroup meetings over the past seven months, and finalizing the report that will be an important springboard into the 2025 Legislative Session. The Accountability Report shares four key recommendations.

- Recommendation 1: Improve Public Transparency and Data Sharing
- Recommendation 2: Review Oregon's Approach to Funding and Investing in K-12 Education
- Recommendation 3: Reduce State Grant Requirements and Reporting
- Recommendation 4: Measure Impact & Take Action

Federal Advocacy Update: Our NASSP and NAESP representatives reported that the federal advocacy work will seek to offer a simplified set of policy priorities with less legislation - this will help to focus our advocacy on key areas where we can make a difference with principal voice.

- Other issue areas that may be advocated for (without a long list of legislation attached to each) are federal support for CTE, career pathways/workforce development, IDEA, student/educator mental health, and school safety
